APPLICANT ELIGIBILITY REQUIREMENTS:

1. Have attended school in Santa Barbara County for at least four of the six years between grades 7-12 *AND* graduate or in addition to graduating or receiving G.E.D. from a Santa Barbara County High School* by June of the current academic year.
2. Be planning to attend full time at a Title IV-approved school in the next academic year.
3. Be a U.S. citizen, permanent resident, or AB 540 eligible

**Homeschooled applicants must have a homeschool affidavit on file with the Santa Barbara County Office of Education. Please submit a copy of the affidavit for each high school academic year 99-12) to the Scholarship Foundation by January 15th. Families of homeschooled and boarding students must have resided in Santa Barbara County for at least four of the six years between 7 and 12.*

***Applicants who are or have been a ward of the Santa Barbara County Court (youth in foster care after the age of 13) residing outside of the county are eligible to apply for our General Scholarship Program*

**** Title IV approval refers to the U.S. Department of Education's guidelines on which institutions are eligible to receive financial aid, including international campuses. Visit <https://fafsa.ed.gov/FAFSA/app/schoolSearch> to search for your institution*

Important Information

- **All applicants** must be planning to attend full-time at a Title-IV approved college, university, vocational school, graduate school, or medical school in the 2017-2018 academic year.
- **All applicants and recipients** must remain in good academic standing and make timely progress towards a degree or vocational certificate.
- **Primary criteria** for scholarship selection are financial need, motivation, and potential.
- **Financial need** is verified by providing a copy of the 2017-2018 Student Aid Report (SAR), generated by the FAFSA or California Dream Act Application.
- **The Foundation** assists students studying in standard academic programs on a traditional academic calendar.
- **The Foundation does not** offer student aid for summer sessions, research, special projects, part-time study, distance learning, or executive MBA-type programs. Online courses will be accepted as long as they are taken from an approved institution and do not exceed more than half of the required minimum full-time units.
