IT IS THE NATION'S LARGEST COMMUNITY-BASED PROVIDER OF COLLEGE SCHOLARSHIPS, HAVING CUMULATIVELY AWARDED IN EXCESS OF \$108 MILLION TO MORE THAN 50,000 COUNTY STUDENTS SINCE ITS FOUNDING IN 1962. IN 2018, THE SCHOLARSHIP FOUNDATION AWARDED A TOTAL OF \$8.32 MILLION TO 2,620 SANTA BARBARA COUNTY STUDENTS. SCHOLARSHIPS FOR UNDERGRADUATES STUDYING AT FOUR-YEAR COLLEGES AND UNIVERSITIES AVERAGED \$3,124. FIFTY-FOUR PERCENT OF THIS YEAR'S RECIPIENTS ARE THE FIRST IN THEIR FAMILY TO ATTEND COLLEGE.
