IT IS THE NATION'S LARGEST COMMUNITY-BASED PROVIDER OF COLLEGE SCHOLARSHIPS, HAVING CUMULATIVELY AWARDED IN EXCESS OF \$123 MILLION TO MORE THAN 50,000 COUNTY STUDENTS SINCE ITS FOUNDING IN 1962. IN 2019, THE SCHOLARSHIP FOUNDATION AWARDED A TOTAL OF \$7.98 MILLION TO 2,447 SANTA BARBARA COUNTY STUDENTS.
