IT IS THE NATION'S LARGEST COMMUNITY-BASED PROVIDER OF COLLEGE SCHOLARSHIPS, HAVING CUMULATIVELY AWARDED IN EXCESS OF \$144 MILLION TO MORE THAN 57,000 COUNTY STUDENTS SINCE ITS FOUNDED IN 1962. IN 2022, THE SCHOLARSHIP FOUNDATION AWARDED A TOTAL OF \$7.7 MILLION TO 2,146 SANTA BARBARA COUNTY STUDENTS.
