IT IS THE NATION'S LARGEST COMMUNITY-BASED PROVIDER OF POSTSECONDARY EDUCATION SCHOLARSHIPS, HAVING CUMULATIVELY AWARDED IN EXCESS OF \$150 MILLION TO NEARLY 60,000 STUDENTS THROUGHOUT SANTA BARBARA COUNTY SINCE ITS FOUNDED IN 1962.
