## Scholarship Foundation of Santa Barbara welcomes April Araujo as Outreach Coordinator for Northern Santa Barbara County



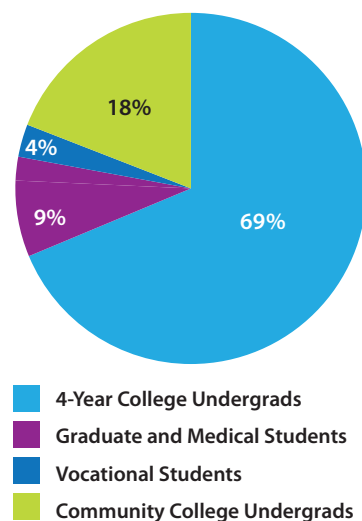
As the Scholarship Foundation expands our program to support more students and families in North Santa Barbara County, we needed a staff person with a deep knowledge of North County schools and community organizations. April Araujo was hired in 2009 to help us with this goal. April was born and raised in Santa Maria and graduated from Santa Maria High School as a first generation, bilingual student. She attended Allan Hancock College and then successfully transferred to UC Santa Barbara where she completed her Bachelor's degree.

While at Allan Hancock College, April worked for the Central Coast Cal-SOAP program, tutoring and mentoring younger students and guiding them through the college admissions and financial aid processes. Subsequently she worked for a local bank, volunteered with CASA, and with a YMCA youth program. In addition, April is a past recipient of student loans and scholarships from the Santa Barbara Foundation and Scholarship Foundation, so she has first-hand knowledge about the financial aid issues facing students and families in our county.

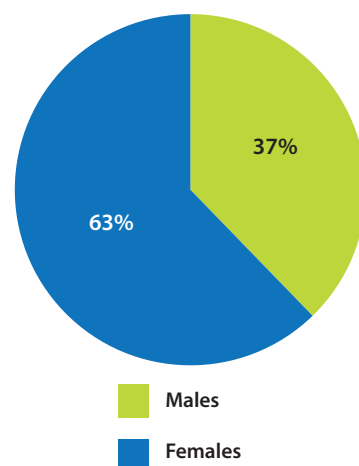

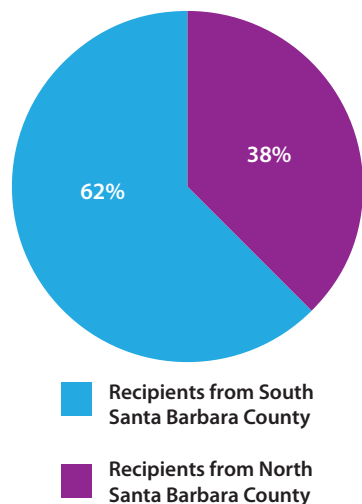
All Scholarship Awards
